### Example 1:

An average zinc price of 2,249 € will result in a zinc regulation of 0,141 €/kg for group B "normal goods".

For group A "heavy goods" the zinc regulation is 0,094 €/kg.

### Example 2:

An average zinc price of 2,901 €/kg will result in a zinc regulation of 0,242 €/kg for group B "normal goods".

For group C "light constructions" the zinc regulation is 0,322 €/kg.

## Zinc regulation

DOT uses the following guidelines for zinc regulations:

### **Group A - (low zinc surcharge)**

This regulation is used for heavy materials (UNP and IPE from 160 and all HEB and HEA in straight lengths from 1.500 – 12.800 mm).

### **Group B - (normal zinc surcharge)**

This regulation is used for normal forging work.

### **Group C - (high zinc surcharge)**

This regulation is used for materials with high zinc consumption (for example pipe materials, welded mesh reinforcement, finned tube or very light constructions).

Zinc is part of the hot-dip galvanizing process where the zinc binds to steel and forms a protective layer. DOT calculates the average zinc price every month which is then used to calculate the zinc regulation.

The zinc regulation will be made in accordance with the average zinc price in the previous month as noted on the London Metal Exchange (LME) - added premium. Premium covers delivery costs, storage, administration and fees for the zinc producer / supplier.

The regulation will be made on the 1st of the month.
